## From the Oklahoma County Sheriff's Office

### Advisory: FRAUD ALERT!

(Oklahoma County) the Oklahoma County Sheriff's Office is issuing a warning regarding phone call complaint that has been reported by an Oklahoma County citizen. According to the reporting party he received a phone call that displayed the number 9-1-1 on his caller identification. When the reporting party answered the phone the caller identified herself as an Oklahoma County Sheriff's Office deputy and gave the badge number 10455.

The caller went on to tell the reporting party that the reporting party had a fraud complaint made against him in the state of South Carolina, and that if the reporting party did not resolve the issue an Oklahoma County Sheriff's deputy would be sent to arrest him. Fortunately the reporting party was suspicious of the call and contacted the Oklahoma County Sheriff's Office to report the incident.

During the phone call the reporting party was verbally given the phone number of (336)308-3196. A simple check through Google shows that the phone number is associated with reported scams nationwide. The Oklahoma County Sheriff's Office advises if anyone receives a phone call like this to:

Get as much information as possible (names, phone numbers, street address, etc.)  
Verify/report the actual law enforcement agency.  
Never release any personal information including social security, banking, etc., over the phone.

Our neighbors at HPNA provided an interesting article as follows:

### Tips on using 911

#### **When do I call 911?**

Dial 911 to report an emergency or to pass on information to the police. If you are not sure, you can call 911 and they will determine if an emergency response is needed. If the 911 operator finds that your call does not meet the emergency guidelines, they will supply you with the telephone number to call the agency that can provide the services needed.

911 is a phone number that is used to get the police, fire department or ambulance services to respond to anything that has to do with safety. It does not have to be an emergency in progress. You may for example, call 911 to report a burglary that was just discovered. When dialing 911 professionally trained call taker receives your call.

A 911 call is free of charge from any phone including a cellular phone. The dispatcher (the person answering the call) can quickly see where the caller is and can send emergency response to your location without the caller giving any information about where they are or what is happening. For example, if someone breaks into your home at night and you are afraid to talk out loud for fear that you might be heard, the dispatcher can send a police officer to your residence to check on your welfare without your even saying a word. **Please note, cell phone users must give the dispatcher their location.**



Frequently Asked Questions regarding The Regulations Of Animals In Del City

**Parents & children, before leaving to work or school, please be sure all animals are secure in the yard or in house. A lot of dogs are running at large because they are not secured before you leave the house.**

Sec. 4-3

Ord. No 882 1, 9-6-88)

This is to inform all Del City residents, of the "At large" or other wise known as the "leash" ordinance and other frequently asked questions.

The term "at large" means not securely confined by a fence or other means (leash) on premises under the control of, or occupied by, the owner, and not under the control of the owner, a member of his immediate family over (12) years of age or an agent of the owner, by leash or otherwise, whether on the owner's premises or not.

Simply stated: The animal must be on a leash even if on your property in the front yard, otherwise in a fenced in area.

How many animals is each household allowed to have: ANSWER: 4

**Puppies:** After puppies are 6 months old, they are considered in your household part of the 4 animals you are allowed to have.

**Kennels:** The term "kennel" means any location where three or more female dogs, for the purpose of breeding, beyond the age of 6 months or a total of five dogs, both male and female, are kept, harbored, boarded, sheltered, or bred.

Is it mandatory to have dogs and cats vaccinated against Rabies. YES. It is not recognized if you purchase the vaccine and give it yourself. It has to be given by a licensed Veterinarian. If the dog isn't wearing the tag, you must have the proper paper work available upon request. It is highly recommended the animal wears the rabies tag so if he does get lost, we can contact you, the owner.

Are Pit Bulls allowed in Del City: Yes

But, no "vicious animals" of any breed is allowed in Del City.

"Vicious Animal" is defined as one not only of disposition to attack a person or animal it may meet, but it includes as well a natural fierceness or disposition to mischief, as may occasionally lead it to attack human beings or animals without provocation
