RESOLUTION NO. 08-03-20A

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEL CITY, ESTABLISHING POLICY FOR FACE COVERINGS OR MASKS TO BE WORN IN INDOOR PUBLIC PLACES WITHIN THE CITY OF DEL CITY TO HELP STOP THE SPREAD OF COVID-19, TO BE IN EFFECT AUGUST 3, 2020 THROUGH AUGUST 31, 2020.

WHEREAS, the United States is experiencing a continuing outbreak of the Novel Coronavirus-2019 also known as COVID-19, and

WHEREAS, the Center for Disease Control ("CDC") has emphasized the COVID-19 risk to individuals is dependent on exposure and transmission is through respiratory droplets produced when an infected person coughs or sneezes; and

WHEREAS, the CDC recommends covering your mouth and nose with a cloth face covering or mask while in public settings and when around people who do not live in your household, especially when other social distancing measures are difficult to maintain.

WHEREAS, social distancing of six feet or more is highly suggested, as well as frequent hand washing with soap and water for at least 20 seconds. When that is not available, hand sanitizer should be used.

WHEREAS, masks or other face coverings that cover the mouth and nose are highly recommended to slow the spread of the COVID-19 virus. When inside a public building, masks or other face coverings are required. Restaurants and other eating and/or drinking establishments are recommended to continue to provide social distancing recommendations for dine-in service. A mask or other face covering is not required outside. Children under the age of twelve (12) are exempt from the requirement of wearing a mask or other face covering. When in City of Del City buildings, masks are required, except that masks are not necessary when individuals are separated by glass or Plexiglas panels. Masks are not necessary in workspaces when employees are separated by six (6) feet or more.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Del City that, except for those with a health concern about wearing a mask, masks are required in indoor public places within the City of Del City. We respect your privacy, and no person shall be penalized for, or questioned about, wearing a mask or not wearing a mask. When in City of Del City buildings, masks are required, except that masks are not necessary when individuals are separated by glass or Plexiglas panels. Masks are not necessary in workspaces when employees are separated by six (6) feet or more.

This policy shall be in effect August 3, 2020 until November 4, 2020.

ADOPTED, PASSED AND APPROVED by the City Council of the City of Del City this 3rd day of August, 2020
